- Each restricted stock unit ("RSU") represents a contingent right to receive one share of the common stock. All unvested RSUs will automatically expire upon Reporting Person's termination of service from Issuer.
- 100% of the RSUs will vest on March 11, 2023; provided, that the Reporting Person continues to provide services to the Issuer through the vesting date.
- The RSUs will vest in three tranches: 1/3 will vest upon the Issuer's common stock achieving a market price of \$30, 1/3 will vest upon the Issuer's common stock achieving a market price of \$38 and 1/3 will vest upon the Issuer's common stock achieving a market price of \$43, in each case during the performance period starting on May 20, 2020 and ending on December 31, 2022; provided, that the Reporting Person continues to provide services to the Issuer through the vesting period.
