The Reporting Person disclaims beneficial ownership of the securities reported herein for purposes of Rule 16a-1(a) under the Securities Exchange Act of 1943, as amended (the "Exchange Act"), except to the extent of his pecuniary interest therein, if any.
- (3) The Reporting Person is contractually obligated to turn over any proceeds from the sale of these shares to GP LLC and/or certain entities affiliated with GP LLC.
